# Youreka's Dreamforce 22 Challenge Official Rules

# 1. Eligibility

Youreka's Dreamforce 22 Challenge (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Youreka Labs, Inc. and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. # 2. Sponsor

# 5. How to Enter

On-Site: This method of entry will be available at Moscone Center, 747 Howard St, San Francisco, California 94103.

Online: This method of entry will be available by visiting our website (https://youreka.io/dreamforce-2022/) and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per person, per email address, and per household for the duration of the Sweepstakes Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

# 6. Prize Drawing

On or about September 27, 2022, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about September 27, 2022. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

# 7. Winner Notification

The winner will be notified by telephone or email. The winner will be required to complete, electronically sign, and submit a Declaration of Compliance and a General Release within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If the winner cannot be contacted or fails to submit the Declaration of Compliance within the required time period (if applicable), or if the prize is returned as undeliverable, the winner forfeits the prize. If the winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the winner's behalf and fulfill any other requirements imposed on the winner set forth herein. # 9. General Conditions

or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of Maryland, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Maryland.

Entrants acknowledge that the Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Bose and release Bose from any and all liability arising from or related to the Sweepstakes.
